Final Walk Sunday, August 29th, 2021 @ 3:00 p.m. Pikwakanagan Bridge to Our Lady of Nativity Cemetery

"The boy stepped onto number four track the most southerly and started running. As he ran he kept looking back over his shoulder then he ran onto the number three track directly in front of the train....the boy was hurled 389 ft." (Globe and Mail)

The newspapers indicated Joe was <u>identified by the number</u> on his institutional uniform and a thumbprint recovered by the coroner. Joe fled the Mohawk Institute in Brantford on September 2 and died on the tracks on September 3 about 6:15 pm. Thanks to the bravery of the residential school survivors who shared their stories, some of which were Joes friends, the family learned about the abuse and horrors the children endured at the institute.

Joe is Pikwakanagan's child that <u>did not make it home</u>. His is a middle child of Dorothy and Allan Commanda. He was a brother, nephew, cousin, uncle and friend to a large number of Pikwakanagan's members.

On August 27, 28 and 29th, Joe's family will be taking a healing walk from the Mohawk Institution in Brantford to Sunnyside Station in Toronto on a route similar to what Joe took on that ill fated day (approx. 98.1 km). Unlike Joe, the family will not be alone, afraid or hunted by police. The family will walk in solidarity with their friends.

Please join Joe's family and his Mohawk friends at the Pikwakanagan Bridge as they complete Joe's journey home.

Parade Route:



Algonquins of Pikwakanagan First Nation Guardian and Algonquin Foods Monitoring/Risk Communication Pilot Programs

The Algonquins of Pikwakanagan First Nation Consultation department has begun to develop a community-based initiative to manage AOPFN cultural and natural resources according to traditional laws and values. The AOPFN Guardian Program will support greater AOPFN member involvement in pre-construction data collection, construction, operations stage and environmental monitoring.

- ⇒ AOPFN has hired DASH 1 as the lead consultant team to develop both programs.
- ⇒ AOPFN members, Dale Benoit Zohr and Sharleen Lavalley, a newly formed Algonquin consultant company(DASH1), along with the Firelight Group, a consultation agency currently working for the AOPFN Consultation department, will co-develop the framework for our Pikwakanagan Guardian program.
- ⇒ DASH1 will seek input and direction from AOPFN knowledge holders, elders and youth.
- ⇒ An AOPFN Guardian program will build capacity and strengthen our Nation by providing training, education, employment and volunteer opportunities.
- ⇒ The program will support our Indigenous rights and responsibilities in protecting and conserving our ecosystems while developing and maintaining sustainable economies.
- ⇒ AOPFN Guardian program will create an opportunity for the Algonquin people to become informed and active participants, Guardians and leaders, in activities occurring within the traditional territory of the Algonquin people.
- ⇒ AOPFN Guardians will be our eyes, ears and boots on the ground and they will protect, enhance, inform and patrol territorial lands.
- ⇒ The AOPFN Guardian program will intertwin Algonquin knowledge, values, laws, practices and western science to develop monitoring programs to give accurate and trusted information to AOPFN.







DIABETIC FOOTCARE CONTEST

For those living with diabetes, a good footcare regime is so very important. Too much glucose in the blood will cause cells to stick together and become blocked in our blood vessels. These blockages can cause a few different problems with our feet:

- Poor circulation: our blood carries oxygen to all parts of our bodies.
 Poor circulation will affect the body's healing abilities which then leads to longer healing times and an increased risk of infection because it has trouble getting blood to the affected areas.
- Neuropathy: this is nerve damage that creates a loss of sensation due to decreased blood flow. Tingling feelings in our feet are the early stages of retinopathy.




