Community Notice

Vaccination Certification Program

The Ontario Government announced that persons will be required to be fully vaccinated and provide proof of their vaccination status to access certain businesses and settings starting September 22, 2021.

As of September 22, 2021, Ontarians will need to be fully vaccinated (two doses plus 14 days after their second vaccination) and provide their proof of vaccination along with photo ID to access certain businesses and settings. This approach focuses on higher-risk indoor businesses and settings where face coverings cannot always be worn and includes:

- Restaurants and bars (excluding outdoor patios, as well as delivery and takeout);
- Nightclubs (including outdoor areas of the establishment);
- Meeting and event spaces, such as banquet halls and conference/convention centres;
- Facilities used for sports and fitness activities and personal fitness training, such as gyms, fitness and recreational facilities with the exception of youth recreational sport;
- Sporting events;
- Casinos, bingo halls and gaming establishments;
- Concerts, music festivals, theatres and cinemas;
- Strip clubs, bathhouses and sex clubs;
- Racing venues (e.g., horse racing).

These requirements are not applicable for outdoor settings where the risk of transmission is lower, including patios. These requirements will not apply to settings where people receive medical care, food from grocery stores, medical supplies, etc. Aligned with public health measures currently in place, indoor masking policies will continue to remain in place.

Ontarians currently have access to a paper and electronic version (i.e., PDF format) vaccine receipt that includes all relevant information to prove that they are fully vaccinated (This would have been emailed to recipients if they provided an email during the time of registration for vaccination). Ontario will be introducing an enhanced digital vaccine receipt that features a quick response (QR) code accessible through your smart phone. There will be more public news and community based information provided in the coming weeks.

If you are required to provide proof of immunization you can access this by downloading or printing your vaccine receipt from the provincial booking portal, or by calling the Provincial Vaccine Booking Line at 1-833-943-3900. **Health Services will be offering assistance to those who are unable to access their vaccine receipt and/or need support, please contact Rachel at 613-625-2259.**

Community Notice

Ontario's 4th Wave

Ontario is now experiencing the "4th Wave" of the Covid 19 virus. The rate of infection is steadily rising mainly due to the highly transmittable Delta Variant. The Provincial Government is implementing new public health policies and reinforcing the existing public health measures to address the 4th Wave of Covid-19. Ontario remains in Step 3 of the Provincial Reopening Plan.

This 4th Wave is predicted to affect the most vulnerable population which includes unvaccinated persons and children under 12. We must carry on with following restrictions and public health measures.

Key public health measures to follow:

- Stay home if you have symptoms, even if they are mild.
- Stay two metres apart from people you do not live with.
- Wear a mask or face covering in indoor public spaces or any time physical distancing is not possible.
- Get covid testing should you have symptoms.
- Get vaccinated if you are not vaccinated.

Pikwakanagan remains at a zero count of Covid-19 cases and now with 88% vaccinated population rate of community members ages 12 and up. The Emergency Response Control Group (ERCG) recognizes the hard work and dedication that each person is doing to keep our community safe. We must remain diligent in our efforts to combat Covid 19. There is light at the end of the tunnel.

The Ontario provincial government health policies include the Vaccine Certification Program (Vaccine Passport) and possible mandatory vaccination workplace settings. More information will be provided in the coming weeks.

Orange Shirt Day, also known as the **National Day for Truth and Reconciliation** is a Canadian statutory holiday. Orange Shirt Day was created as an observance in 2013, and is designed to educate people and promote awareness in Canada about the Indian Residential School system and the impact it has had on Indigenous communities for over a century—an impact recognized as a cultural genocide, and the inter-generational impacts that is still felt today in our families and communities. Communities across the nation hold annual events on September 30 in recognition of the historical experiences that Indigenous Peoples have endured during the Residential School era. People wear an orange shirt as a reminder that **Every Child Matters!**

The inspiration for Orange Shirt Day came from Residential School Survivor, Phyllis Jack Webstad, who shared her story at a St. Joseph Mission (SJM) Residential School Commemoration Project and Reunion event held in Williams Lake, British Columbia, in the spring of 2013. Phyllis recounted her first day of residential schooling at six years old, when she was stripped of her clothes, including the new orange shirt her grandmother bought her, which was never returned. The orange shirt now symbolizes how the Residential School system took away the Indigenous identities of its students, which in turn impacted our families and communities for generations after.

Today, Orange Shirt Day exists as a legacy of the SJM Project, and September 30, the annual date of the event, signifies the time of year when Indigenous children were historically taken from their homes to Residential Schools. The official tagline of the day, "Every Child Matters," reminds Canadians that all peoples' cultural experiences are important.

In addition to simply wearing an orange shirt, Canadians are encouraged to learn more about the history of residential schools and their assimilation practices, drawing from Phyllis' experience in particular. For instance, many communities have held memorial walks, film screenings, and public lectures to raise awareness about Indigenous history. Accordingly, school boards across Canada have begun to use this event to teach children about the historic system.

On September 30th, the Algonquins of Pikwakanagan First Nation will be honouring our children and youth, past, present, and future through a community video and feast. The Every Child Matters (ECM) Task Force has identified several ways for our members to acknowledge this important day. Although the historic significance of this day is very sad for many people, the ECM Task Force believes this is a day to celebrate. We are all here today because our ancestors and families have survived the Residential School era. We are celebrating our resiliency, and our Anishinabe language, culture, and traditions. We are proud to be Anishinabeg!

The Every Child Matters Task Force are once again, asking for our members' assistance to make this day a meaningful and memorable day for all. Orange shirts have been ordered for residents of Pikwakanagan. We are providing these shirts so Pikwakanagan community members can wear their shirts in Pride on September 30th. Also, we ask families to make photos or videos to share "What Orange Shirt Day September 30th Means to Us". These photos and videos will be compiled into a video that will be released on September 30th to share with all our members. Your participation is needed to help us make this a beautiful commemoration for all Residential School Survivors.

As well, a wonderful meal will be provided to members on this day. This will be a Drive-Thru event.

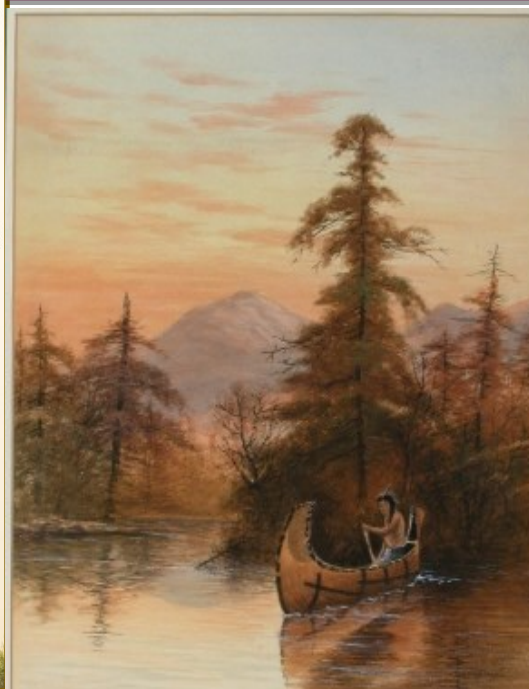

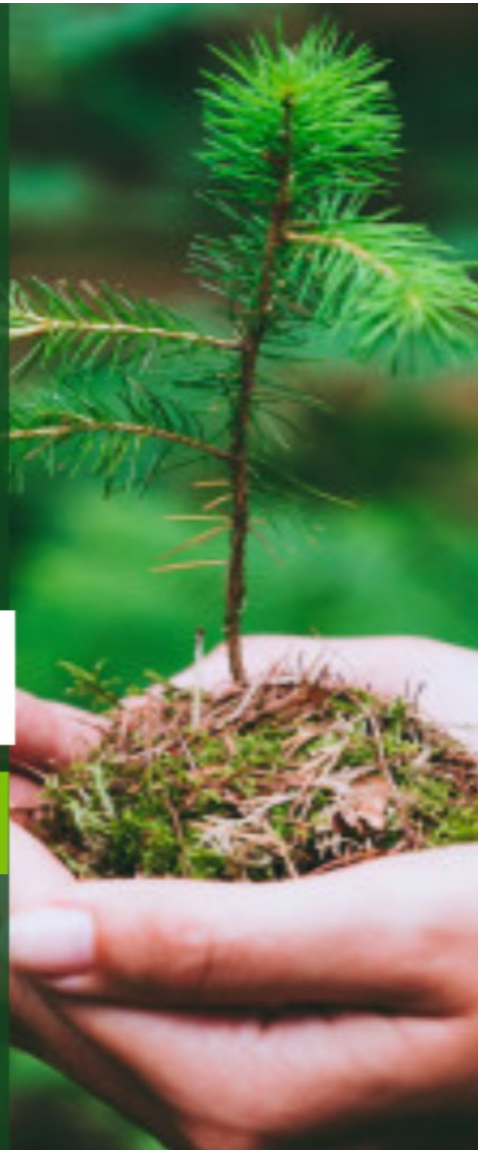

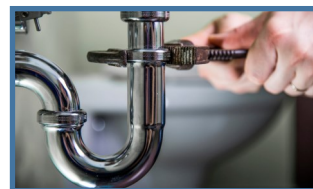

Algonquins of Pikwakanagan First Nation Community Helper Position

The AOPFN Consultation Office is advertising for a temporary Community Helper opportunity to assist with the First Nation Conservation Program and their efforts to make our community more energy efficient.

The Community Helper will assist the energy assessor when they visit various homes in Pikwakanagan to help the homeowners feel more at ease by having a familiar community member present. These visits will occur daily from September 27—October 8, 2021 (excluding October 2 & 3).

Duties include:

- Install LED light bulbs;
- Install kitchen/bathroom aerators and shower-head (if required);
- Set up power bar with timer (if required);
- Wrapping the hot water tank with tank wrap insulation (assist Assessor);
- Applying pipe insulation to hot water pipe to existing tank (assist Assessor);
- Leave program brochure with participant;
- Assist Assessor with any clean up and loading old bulbs into recycling boxes.

We recommend that the Community Helper be fully vaccinated, due to the severity of the Covid-19 Pandemic. Covid-19 protocols must be followed, and Personal Protect Equipment (PPE) will be provided.

The Community Helper will be paid \$20 per home and a gas allowance will also be provided.
