Ontario's 4th Wave

Ontario is now experiencing the "4th Wave" of the Covid 19 virus. The rate of infection is steadily rising mainly due to the highly transmittable Delta Variant. The Provincial Government is implementing new public health policies and reinforcing the existing public health measures to address the 4th Wave of Covid-19. Ontario remains in Step 3 of the Provincial Reopening Plan.

This 4th Wave is predicted to affect the most vulnerable population which includes unvaccinated persons and children under 12. We must carry on with following restrictions and public health measures.

Key public health measures to follow:

- Stay home if you have symptoms, even if they are mild.
- Stay two metres apart from people you do not live with.
- Wear a mask or face covering in indoor public spaces or any time physical distancing is not possible.
- Get covid testing should you have symptoms.
- Get vaccinated if you are not vaccinated.

Pikwakanagan remains at a zero count of Covid-19 cases and now with 88% vaccinated population rate of community members ages 12 and up. The Emergency Response Control Group (ERCG) recognizes the hard work and dedication that each person is doing to keep our community safe. We must remain diligent in our efforts to combat Covid 19. There is light at the end of the tunnel.

The Ontario provincial government health policies include the Vaccine Certification Program (Vaccine Passport) and possible mandatory vaccination workplace settings. More information will be provided in the coming weeks.

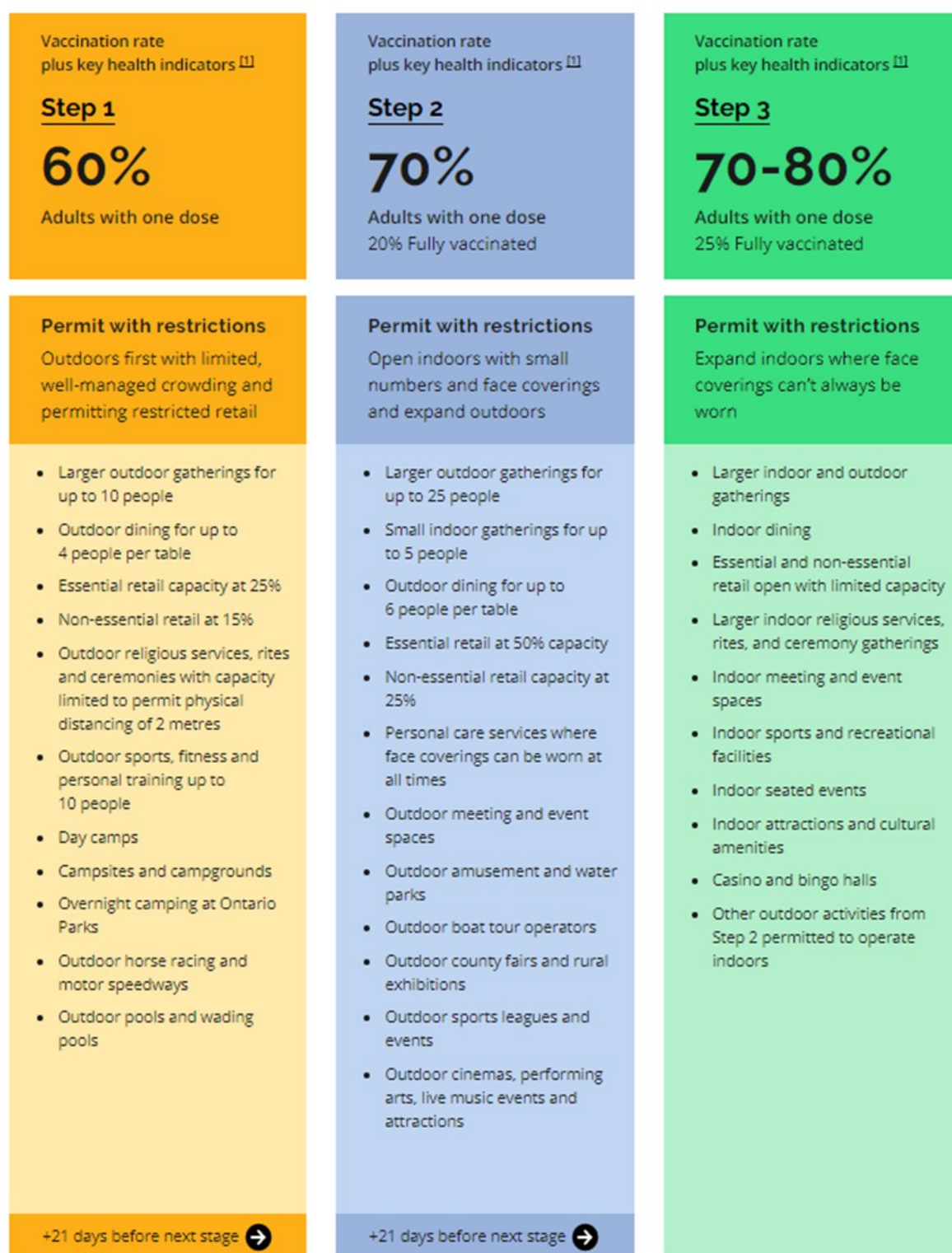

Introduction to the Algonquin Anishinaabeg – A Reading Course

In the spirit of reconciliation and the need to respect the nation-to-nation relationship . . .

The Algonquin Anishinaabeg residing in what is now called the Ottawa River Valley were one of the first Indigenous Nations in the European record. Traditional Algonquin Anishinaabeg territory was located at the heart of what became Upper and Lower Canada in 1791.

Today, in 2021, the seat of Canada's parliament illegally squats on Algonquin territory, yet many of Canada's citizens are unaware that the Algonquin Nation hosts their parliament. Further, many Canadians are unaware that although the Algonquin were allies to the French during the Seven Years War (1756-1763), and allies to the British during the American revolution in 1776, the Algonquin have never signed a land treaty with the French or British. Thus their land remains unceded.

In this 10-week reading course participants will be exposed to Algonquin contact history, Algonquin politics, and Algonquin culture. Through this learning opportunity you will learn that the genocide imposed on the Algonquin Nation is synonymous with the creation of Canada.

Course Duration: 10 weeks from Oct 4, 2021 through Dec 6, 2021. One Zoom lecture will follow on Dec 9, 2021 at 7:00 pm EST. Course Director: Dr. Lynn Gehl, Algonquin Anishinaabe-kwe and member of Pikwakanagan First Nation. Cost: \$100. Space is limited.

POTENTIAL WITHDRAWAL OF EYE EXAM SERVICES BY ONTARIO OPTOMETRISTS

Indigenous Services Canada's (ISC) Non-Insured Health Benefits (NIHB) program provides registered First Nations and recognized Inuit in Canada with coverage for a range of health benefits, including vision care benefits. In Ontario, vision care exams for residents up to the age of 19 and those 65 or older, and those with specific medical conditions, are an insured service covered by the province of Ontario.

The NIHB Program is aware that Ontario optometrists are currently in a fee dispute with the Province of Ontario, and that the Ontario Association of Optometrists may withdraw insured vision care services as of September 1, 2021. According to Ontario law, provincially insured services must be billed to the province. Optometrists cannot bill the client or another insurance provider for insured services. This includes provincially insured eye exams. The NIHB Program is not able to pay for services that are, by law, insured by the province in Ontario.

We encourage Ontario NIHB clients who have an upcoming appointment for a vision care exam with an optometrist to call ahead to confirm their appointment if they are:

- 19 and under,
- 65 and older,
- Or have a medical condition including diabetes mellitus, glaucoma, cataract, retinal disease, amblyopia, visual field defects, corneal disease, strabismus, recurrent uveitis, and optic pathway disease.

Impacted clients may wish to consider re-booking their appointment to a later date, once the fee dispute has been resolved.

Ontario NIHB clients who are 20-64 years of age are not impacted.

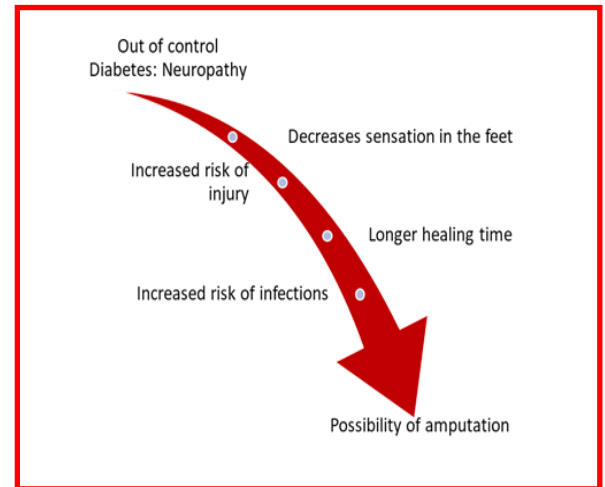

DIABETIC FOOTCARE CONTEST

For those living with diabetes, a good footcare regime is so very important. Too much glucose in the blood will cause cells to stick together and become blocked in our blood vessels. These blockages can cause a few different problems with our feet:

- Poor circulation: our blood carries oxygen to all parts of our bodies. Poor circulation will affect the body's healing abilities which then leads to longer healing times and an increased risk of infection because it has trouble getting blood to the affected areas.
- Neuropathy: this is nerve damage that creates a loss of sensation due to decreased blood flow. Tingling feelings in our feet are the early stages of retinopathy.



There are ways to decrease the possibility of foot complications from your diabetes:

Controlling blood-glucose levels
Taking prescribed medications properly
Staying active
Eating healthfully
Having a daily footcare regimen at home
Seeing your footcare specialist on a regular basis
Wearing proper footwear

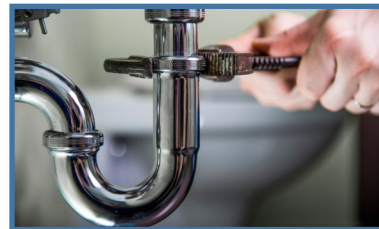
