Community Notice

New Christmas Restrictions

To prevent the rapidly spreading and highly transmissible Omicron variant, the Ontario government in consultation with Chief Medical Officer of Health, is implementing additional public health and workplace safety measures. These measures are help limit transmission and continue to protect the hospitals and ICU capacity as the province continues to accelerate its booster dose rollout.

All social gatherings limit to 10 people indoors and 25 people outdoors.

50% capacity limit in the following indoor public settings:

- Restaurants, bars and other food or drink establishments and strip clubs;
- Personal care services;
- Personal physical fitness trainers;
- Retailers (including grocery stores and pharmacies);
- Shopping malls;
- Non-spectator areas of facilities used for sports and recreational fitness activities;
- Indoor recreational amenities;
- Indoor clubhouses at outdoor recreational amenities;
- Tour and guide services;
- Photography studios and services;
- Marinas and boating clubs;
- Facilities used sports and recreational fitness activities;
- Entertainment facilities such as concert venues, theaters and cinemas;
- Racing venues;
- Meeting and event spaces;
- Studio audiences in commercial film and television production;
- Museums, galleries, aquariums, zoos, science centres, landmarks, historic sites, botanical gardens and similar attractions;
- Casinos, bingo halls and other gaming establishments; and
- Fairs, rural exhibitions, and festivals

Notice to Businesses

Enforcing Public Health Safety Measures

The Omicron Virus has been detected worldwide, Canada, Ontario and in Renfrew County. It has a doubling factor of 2.8 days and there are thoughts that the real number of cases is considerably more than the 4100 covid cases recently reported in Ontario.

To this point, we have had no reported cases.

The Community has been urging businesses to maintain the public health measures and have provided support, mentoring and resources. Businesses have had to conform to the changing Covid public health measures.

Everyone is Covid-fatigued. We understand.

Businesses need to review their COVID-19 processes and make improvements. They must follow the public health measures for the safety of employees and the community. Failure to do so can lead to business closures and community lockdown should there be positive cases in the community.

The following is recommended for businesses:

- Post a safety plan.
- Provide passive screening to patrons (posting on entrance doors).
- Staff complete active screening and if sick, stay at home.
- Staff working in or out of doors should wear a medical grade mask that covers their nose, mouth, and chin when serving patrons and/or when in proximity to coworkers.
- Use a glass partition or plexiglass divider.
- Plan for routine and as-needed cleaning and sanitizing.
- Gas bars should not allow patrons to get out of their vehicles.
- Restaurants to be at 50% capacity.
- Restaurants need to register patrons, and patrons must show proof of vaccination. (Dec 2021)
- Provide a means to social distancing.
- All patrons entering a business should have a mask on and have hand sanitizer available for their use.

Pikwakanagan businesses are heavily trafficked areas encountering numerous customers daily, many of whom may not be from Pikwakanagan or are travelling from various distances.

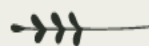

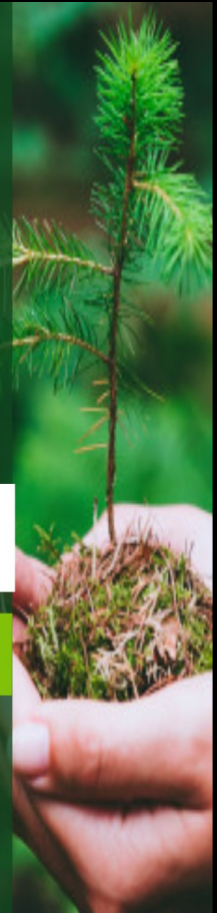
