- If a non-member spouse is moving with you, they must complete a separate "Non-Member Application" Form.
- Your name and date of residency will be posted at the Administration Office. This information is required to access certain Pikwakanagan programs and services such as School Bus Transportation and Housing etc.
- Pikwakanagan's laws are available at the Administration Office and it will be your responsibility to be informed.
